This produced a lot of discussion on the subject of what impact it will have on the Saxham community, light pollution, noise disturbances, volume of traffic etc. We have been asked by Risby Parish Council to work alongside them as our concerns are very similar The Clerk was asked to make enquiries into obtaining an extension on the Consultation Period

It was clear that very few villagers are aware of the AJN Steelstock planning application and those that are have many concerns. Councillors think it would be useful to organise a public meeting, perhaps by leafleting all households, possibly to be held jointly with Risby Parish Council. Cllr.
