- 4. Matters Arising from Minutes 13<sup>th</sup> Sept 2023
  - Great Saxham Playground Update on Outstanding Issues

The two new benches still need to be made more secure lower down the bank. Cllr. Hopkinson will progress this either with assistance from George Gittus or via another local volunteer. The Parish Council will readily pay for any costs involved.

Cllr. Hopkinson

Cllr. Ferguson is assessing the overall condition of the existing Play Equipment with appropriate suppliers as there are several items of equipment where timber has begun to rot. The councillors requested that enquiries should be made into getting this equipment repaired or consideration given to replacements, if necessary. Cllr. Ferguson is to look into this with the possibility of acquiring a Locality Grant.

The poor condition of the existing wooden benches (listed under 'moderate risk') continues to be monitored through the monthly Play Area Report by W.S. Council and the replacement of the feet will be dealt with once the new benches are in place.

# • "The Stile" Newsletter – numbers required for Great and Little Saxham

The Clerk has been corresponding with Risby Village Hall Charity to make sure the Parish Council is billed accordingly and a new invoice was issued for the corrected number of 120 (at a discounted rate for the current year only) of £4.50.

Since expressing an interest in having "Quiet Lane" signs in Great Saxham from Nutmeg Gates through to Hargrave Road in order to encourage lower speed, Cllr Burt has been making enquiries along with the assistance of Councillor Karen Soons.

This section of road has now been registered with the Suffolk Highways Safety and Speed Management department. They are currently looking into the process needed to designate new Quiet Lanes with the associated costs and so will come back to the Parish Council in due course.

# **Road Closures: New Gas Pipeline for Direct Table Foods**

An update by Cllr Burt was given outlining that repairs continue to take place along the road to the Cattery in little Saxham and that the final stages of the pipework will be completed on Honey Hill resulting in a further 2 week closure of the road.

Unfortunately, it was reported that the Parish Council have had no luck with Direct Table Food in gaining any compensation for the inconvenience caused **Cllr. Jones** by the road closure. Cllr. Jones will look into this once more.

# **Electric Charging Point – Great Saxham Layby**

Cllr. Hopkinson has contacted Anglian Water, the owners of the Lay-by at Twites Corner and they have made it clear that the space must be generally available for their maintenance vehicles. Councillors agreed that there seemed to be no benefit to the village from the introduction of a Public recharging point and so this does not appear to be a viable project.

#### **Lodge Farm Development Little Saxham**

The listed farmhouse and adjacent farmyard had been sold in two lots to the same buyer and the Parish Council will continue to monitor the development plans closely.

# Village Sign for Little Saxham

Cllr. Jones will continue his research into a village sign for Little Saxham and look into different areas of funding that might be available. An update **Cllr. Jones** will hopefully be provided at the next meeting.

# Proposal AJN Steelstock at the site of Newmarket Road

Cllr. Burt reported that he had made formal enquiries with West Suffolk Council Planning Officer Mr Gary Hancox in relation to the AJN Steelstock Application. He was informed that they were responding to comments received and that an amended planning application would be submitted with a new Consultation Period, where we will be able to comment once more; with a decision being made early in 2024.

As suggested, the Council felt it would be beneficial to be able to correspond with residents, collect feedback and gain people's views on it and also with **Cllr. Burt** any future projects. The Chairman will prepare a bulletin to be distributed with the Stile which would cover current issues. The Parish Council have looked into making a GDPR registration under the Information Commissioners Office (ICO) as there will be a need to collect and hold Michelle individual email addresses and personal details. This would therefore be **Thompson** beneficial for the Parish Council as it would enable them to inform the Parishioners of the village about not only the above proposal but future projects and events. The ICO make an annual charge of £35 for payment by Direct Debit which was approved by Councillors.

#### **Chestnut Tree at Twites Corner**

Further enquiries had been made by Cllr. Hopkinson and it appears that the land is the responsibility of Anglian Water. They have since been out to inspect the trees and have appointed a contractor to cut them back. The Council thanked Cllr. Hopkinson for her efforts in finally establishing ownership.

# Barrow cum Denham Neighbourhood Plan

Barrow cum Denham had published their draft Neighbourhood Plan. Based on previous comments made by the Saxhams Parish Council regarding housing developments in Barrow, Cllr. Burt has recorded the following comments in regards to the consultation for the Neighbourhood plan

The Barrow Neighbourhood Plan must stress that expansion of this Key Service Centre is supported by appropriate upgrades to facilities and infrastructure so that neighbouring villages such as Little Saxham and Great Saxham are not unfairly impacted. Specifically the Primary Healthcare Centre and Barrow CEVC Primary School capacity must increase in line with the proposed developments.

The Neighbourhood Plan focuses residential development to the South of the village thereby requiring negotiation of a traffic-calmed and congested route through the centre of Barrow to access the A14 J40 to travel East or West. Further consideration should be given to expanding the settlement boundary to the North of the village to allow housing allocation adjacent to the School to overcome this problem and reduce traffic flows that will impact on other local villages.

Burt also spoke about the road leading up from Honey Hill to meet Bury Road, which has just been repaired, but unfortunately there are no "Giveway" signs to indicate which vehicle direction has access. These matters to be reported to SCC Highways and highlighted to County Councillor Karen Soons at the next meeting.
